1. All Aquatic Center and Pool Rules will be enforced.
2. Final payment must be received and registration confirmed fifteen days (15) in advance of the rental date. Rentals will be dropped if payment is not received.
3. If you wish to cancel, you must do so no later than 5 days (5) prior to rental. There is a \$10.00 cancellation fee which will be deducted from security deposit.
4. If weather conditions force a pool closure, the YMCA will re-schedule your rental, issue a voucher, or issue a refund upon request.
5. The contact person must bring their copy of this rental agreement to the pool prior to the group's
6. YMCA Staff reserves the right to deny any person entry to the pool who poses a clear health or safety risk to other pool patrons.
7. Food and beverage may not be brought into pool area. Picnic tables are provided outside Aquatic Center.
